Assessed Activities:

The proposal for conferring the title Associate Professor and appointing the title Professor assesses the applicant as a complex educational and scientific personality and takes into account his/her whole work in compliance with the valid regulation of the Ministry of Education of the Slovak Republic No. 246/2019 Coll., about the procedure of acquiring the scientific and pedagogical titles and artistic and pedagogical titles Associated Professor and Professor as amended. The acceptation of the applicants by the scientific and Professional community is important!

- (2) The criteria for assessing the fulfilment of the conditions for acquiring the scientific and pedagogical title Associate Professor and Professor at the UNIZA faculty of Mechanical Engineering were discussed by the Scientific Council of the Faculty of Mechanical Engineering on 25th March 2022.
- (3) The criteria comply with the Guideline 211 and Appendix 1: Minimal Criteria of UNIZA for Habilitation and Inauguration Proceedings and Staffing the Functional Positions of Associate Professor and Professor for Specialisations of Habilitation and Inauguration Proceedings Attached to the Following Specialisations: Transport, Economy and Management, Mechanical Engineering, Cybernetics, Informatics, Electrical Engineering, Civil Engineering, Security Sciences.
- (4) The UNIZA Scientific Council approved the criteria for assessing the fulfilment of the conditions for acquiring the scientific and pedagogical title Associate Professor and Professor at the UNIZA Faculty of Mechanical Engineering on 21st April 2022 and on this day, they come to power. They become effective on the day of their publishing.
- (5) On 21st April 2022 the criteria for assessing the fulfilment of the conditions for acquiring the scientific and pedagogical title Associate Professor and Professor at the UNIZA Faculty of Mechanical Engineering approved by the UNIZA Scientific Council on 19th November 2020 were cancelled.

Explanatory Notes

Pedagogical Activity

- A mimeographed output is considered a teaching text determined for the university whose task is to substitute the university textbook for a certain period of time. The mimeographed output has to pass an official publication process, to fulfil the criteria of a generally issued publication and has to possess all necessary prerequisites of the formal and publishing adaptation according to the valid standards. The mimeographed output has the necessary publishing data and assigned ISBN. If the mimeographed output is not registered in CREPČ, the author has to prove the editorial proceedings. A co-author with the total share of minimally 3 quires can be considered the author for the purposes of fulfilling the criteria.
- A university textbook is considered a teaching text that gives a systematic and explanatory overview of knowledge from a scientific discipline or social practice. The textbook before its issue is assessed at least by two experts whose names are presented in the publication. The university textbook has the necessary publishing data and assigned ISBN. If the mimeographed output is not registered in CREPČ, the author has to prove the editorial proceedings. A co-author with the total share of minimally 3 quires can be considered the author for the purposes of fulfilling the criteria. *

Scientific and Research Activity

- A scientific monograph is considered an original monothematic work with scientific and exploration character, in which the author utilises, critically assesses and synthesises the known knowledge about the given topic and enriches it by new original phenomena that are the results of the author's scientific activities. The monograph is assessed by the scientific editor and at least two experts whose names are presented in the publication. The monograph is to be published at least in 100 copies; it has the necessary publishing data and assigned ISBN. If the monograph is not registered in CREPČ, the author has to prove the editorial proceedings. A co-author with the total share of minimally 3 quires can be considered the author for the purposes of fulfilling the criteria. If there is a chapter in the monograph (the author share is 1 quire), it is possible to register it as an original scientific work in part V1.
- A magazine is considered a periodical publication that is issued in regular weekly up to half-year intervals,
 i.e. minimally twice a year; it contains articles by several authors and has a defined programme and specific
 orientation. The magazine has the necessary publishing data and assigned ISBN. If the magazine is not
 registered in CREPČ, the author has to prove the editorial proceedings.
- An anthology is considered a publication that summarising under a common title brings a file of
 independent, mutually familiar texts. The individual parts (articles, studies) could exist independently. There
 can be the conference, non-conference, single purpose or continual anthologies. The anthology has the
 necessary publishing data and assigned ISBN, or ISBN and ISSN. If the magazine is not registered in CREPČ,
 the author has to prove the editorial proceedings.
- All the publications and citations have to be registered.

^{*} Quire: 36,000 characters (20 standardised pages, 1 page = 1,800 characters), in the case of the maps and geographical images $2,300 \text{ cm}^2$ (the quire's dimension is approximately 48 cm x 48 cm), video audio published on the internet or a physical carrier in the extent of at least 60 minutes.
